

Call for Proposals:

Audit Services for Grants received by the UK Foreign, Commonwealth and Development Office

1. Introduction

Perspectives Climate Research gGmbH is seeking to procure audit services to conduct reasonable assurance engagements in connection with grants received from the Foreign, Commonwealth and Development Office (FCDO) of the United Kingdom for the projects “Enhancing Nigeria's Capacity in Global Climate Negotiation” (short: Nigeria negotiation capacity) and “Accelerating ASEAN’ Inclusive Low-Carbon Transition and Resilient Economic Development by Strengthening Climate Action & Article 6 Readiness” (short: ASEAN STRIDE).

2. Objectives of the Assignment

The objective of the audits is to provide independent reasonable assurance reports on the financial statements and grant claims of Perspectives Climate Research gGmbH ensuring compliance with the terms of the grant agreements and relevant legislation.

3. Scope of Work

The audit firm will be required to:

- Conduct the audit in accordance with ISAE 3000 (Assurance engagements other than audits and reviews of historical financial information).
- Review the financial statements and grant claims to ensure they are prepared in accordance with the grant agreement.
- Verify that the expenditure reported is eligible and incurred in accordance with the grant agreements.
- Provide reasonable assurance reports on the financial statements and grant claims.
- Ensure that all goods and services financed either fully or in part from FCDO funds are used for the intended purposes.

Perspectives Climate Research gGmbH will:

- Provide the audit firm with all necessary records, correspondence, information, and explanations required for the project audit

6. Eligibility and Required Qualifications

Interested audit firms should demonstrate:

- Proven experience in delivering high quality audit reports
- Demonstrated expertise in international and/ or UK PACT auditing reports
- Strong understanding of grants management and legislation
- Membership of the International Federation of Accountants
- Experience in auditing non-profit organisations
- Fluency in English (minimum C1 level)
- Experience in conducting the audit in accordance with ISAE 3000 (Assurance engagements other than audits and reviews of historical financial information).
- Ensure confidentiality

7. Reporting and Coordination

The auditor will report to the Perspectives Climate Research Grants Manager or designated focal point and will coordinate closely with:

- The Perspectives Climate Research finance team and project manager
- The Grantor *Palladium International Ltd* (if required)
- The funding institution *Foreign, Commonwealth and Development Office* of the UK (if required)

8. Submission Requirements

Interested bidders should submit the following:

- A brief company profile and relevant experience
- Description of the proposed technical approach and staffing
- CV(s) of proposed personnel
- Indicative cost proposal with a clear breakdown of daily rates and an estimate regarding average work hours required for creating the deliverables (section 4)
- At least one reference from similar assignments
